COMPOSITION

Each capsule contains:

1. Bacopa Monneri Extract	160mg
standardized to 25% of total Bacosides (Bacoside A & B)	
2. Ashwagandha extract	150mg
3. L-Theanine	100mg
4. Bioperine	5mg

PHARMACOLOGICAL CLASSIFICATION

Category D: Complementary Medicine

INDICATIONS

Neuro- k capsules is specifically indicated for the treatment of symptoms related to the following:

1. Anxiety and stress disorder
2. Mental fatigue
3. Memory and concentration disorders
4. Memory disturbances

CONTRA-INDICATIONS

Known hypersensitivity to any of the ingredients.

Children younger than 12 years of age.

PHARMACOLOGICAL ACTION

Bacopa monneira contains bacosides that promote nerve impulse transmission through the reparation of damaged neurons. Thus, It restores the synaptic activity of neurons.
Ashwagandha is an adaptogen, which has a unique ability in helping the body manage stress by causing adaptive reactions to disease and stress.

L-Theanine increases serotonin, dopamine, GABA and glycine levels in the brain, and thus reduces mental and physical stress.

Bioperine increases the bioavailability and absorption of the three main active ingredients in NEURO-K.

DOSAGE AND DIRECTIONS FOR USE

Adults only: (12 years and older) take two capsules after breakfast, or as recommended by your healthcare practitioner.

WARNINGS

Do not exceed recommended dose.
If you experience any allergic reaction after taking NEURO-K capsules, discontinue use and consult a healthcare practitioner.

SIDE-EFFECTS AND SPECIAL PRECAUTIONS

No known side effects.

PREGNANCY AND LACTATION

The use of NEURO-K during pregnancy and lactation has not been fully studied and should only be used in these circumstances under the guidance of a healthcare professional.

KNOWN SYMPTOMS OF OVERDOSAGE AND PARTICULARS OF ITS TREATMENT
