Visit a healthcare professional if symptoms do not improve after 30 days.

COMPOSITION

Each capsule contains:

1. Cinnamon Extract 75mg
2. Fenugreek Extract 10mg
3. Amla Extract 50mg
4. Pterocarpus Marsupium 75mg
5. Gymnema Sylvestre extract (75 % gymnemic acid) 75mg

PHARMACOLOGICAL CLASSIFICATION

Category D: Complementary Medicine.

INDICATIONS

Blood Sugar Support capsules is specifically indicated for the treatment of symptoms related to the following:

1. Managing blood sugar levels
2. Managing insulin resistance

CONTRA-INDICATIONS

Known hypersensitivity to any of the ingredients.

Children younger than 12 years of age.

Not recommended for people on blood-thinning medication, unless otherwise advised by a healthcare professional.

Not recommended for people on the herb St. John's Wort, because this may increase Gymnema's blood-sugar-lowering consequences, unless otherwise advised by a healthcare professional.

PHARMACOLOGICAL ACTION

Amla extract helps insulin resistance and balances high blood sugar levels. It eliminates toxins from the body and heals cellular metabolism. Fenugreek extract has shown to have antidiabetic properties by reducing intestinal glucose absorption, delay gastric emptying, improves insulin sensitivity and action, and reduces concentration of liquid binding properties.

Gymnema Sylvestre may stimulate insulin production in your pancreas, promoting the regeneration of insulin-producing islet cells. The mode of action of the drug is through stimulation in insulin secretion from pancreas. It also exerts a similar effect by delaying the glucose absorption in the blood.

Cinnamon can lower blood sugar by acting like insulin and increasing insulin's ability to move blood sugar into cells.

DOSAGE AND DIRECTIONS FOR USE

Adults only: (12 years and older) take one capsules after breakfast, or as recommended by your healthcare practitioner.

WARNINGS

Do not exceed the daily recommended dose.

If you experience any allergic reaction after taking Blood Sugar Support capsules, discontinue use and consult your healthcare practitioner.

When taken with other diabetic medication, Blood Sugar Support may reduce the blood sugar level and might cause hypoglycaemia. Blood Sugar Support might cause a reduction in the amount of diabetic medication required.

Please consult with your medical practitioner before reducing your medication.

If type 1 Diabetic, do not use without the strict supervision of your medical professional. For type 2 diabetes, the extracts will lower blood glucose, so medication needs to be adjusted and supervision of medical practitioner is needed

SIDE-EFFECTS AND SPECIAL PRECAUTIONS

Less frequent in therapeutic doses.

Possible side effects of Fenugreek include:

- Allergic reaction.
- Asthma.
- Diarrhoea.
- Gas (flatulence)
- Low blood sugar (hypoglycaemia)
- Wheezing.
- Unusual body odours

Possible side effects of Gymnema Sylvestre

- Dizziness
- Nausea
- Shakiness
- Light-headedness

Discontinue use before surgery due to bleeding risk factors.

Gymnema isn't to be used by people experiencing hypoglycaemia. Patients on drugs for diabetes are advised to use caution, monitor their glucose levels, and to consult their healthcare provider when thinking of a program that integrates Gymnema.

Gymnema Sylvestre supplements shouldn't be taken at precisely the exact same time as blood-sugar-lowering drugs, including insulin shots.

Consult with your doctor about the best time for taking this supplement.

PREGNANCY AND LACTATION

The use of Blood Sugar Support during pregnancy and lactation has not been fully studied, and should only be used in these circumstances under the guidance of a healthcare professional.

KNOWN SYMPTOMS OF OVERDOSAGE AND PARTICULARS OF ITS TREATMENT

In the event of an overdose or suspected overdose and (notwithstanding the fact that the person may be asymptomatic) the nearest doctor, hospital or Poison Control Centre should be contacted immediately.

PRESENTATION

Blood Sugar Support is available in a bottle containing 30 capsules.

STORAGE INSTRUCTIONS

Store in a well closed container, in a cool dry place and away from direct sunlight.

Store at or below 25°C.

Keep out of reach of children.
